

End User License Agreement

HITS-UK COPDfast LICENSE AGREEMENT

BY CLICKING THE "I ACCEPT" BUTTON, DOWNLOADING THIS SOFTWARE OR USING THIS SOFTWARE, YOU AGREE TO BE BOUND BY THIS LICENSE AGREEMENT. IF YOU DO NOT AGREE TO THIS LICENSE AGREEMENT, DO NOT DOWNLOAD THE SOFTWARE OR USE THE SOFTWARE.

1. ACCEPTANCE OF TERMS

HITS-UK provides its COPDfast software to you, subject to the following License Agreement ("AGREEMENT"), which may be updated by us from time to time without notice to you. You can review the most current version of the AGREEMENT at any time at www.HITS-UK.com. In addition, you shall be subject to any posted guidelines or rules applicable to the COPDfast software which may be posted from time to time. All such guidelines or rules are hereby incorporated by reference into the AGREEMENT.

2. DESCRIPTION OF SOFTWARE

HITS-UK's COPDfast software (the "Software") assists in the clinical diagnosis of COPD in a medical environment, used by qualified medical personnel. Unless explicitly stated otherwise, any new features that augment or enhance the current software shall be subject to the AGREEMENT. You understand and agree that the Software is provided "AS IS" and that HITS-UK assumes no responsibility for the deletion, misdelivery or failure therein. You are responsible for obtaining access to the Software and that access may involve third party fees (such as Internet software provider charges).

3. INDEMNITY

You agree to indemnify and hold harmless HITS-UK, and its subsidiaries, affiliates, officers, agents, vendors or other partners, and employees, harmless from any claim or demand, including reasonable attorneys' fees, made by any party due to or arising out of your use of the Software, your connection to the Software, your violation of the AGREEMENT, or your violation of any rights of another.

4. MODIFICATIONS TO SOFTWARE

HITS-UK reserves the right at any time and from time to time to modify or discontinue, temporarily or permanently, the Software (or any part thereof) with or without notice. You agree that HITS-UK shall not be liable to you or to any third party for any modification, suspension or discontinuance of the Software. The unlicensed version of the Software expires 30 days after installation after which it may not be used.

5. TERMINATION

You agree that HITS-UK may, under certain circumstances and without prior notice, immediately terminate your access to the COPDfast software. Cause for such termination shall include, but not be limited to: (a) breaches or violations of the AGREEMENT or other incorporated agreements or guidelines, (b) a request by you, (c) discontinuance or material modification to the Software or any part thereof, (d) unexpected technical or security issues or problems, (e) extended periods of inactivity, and (f) you have engaged in fraudulent or illegal activities. Further, you agree that all terminations shall be made in HITS-UK's sole discretion and that HITS-UK shall not be liable to you or any third-party for any termination of your access to the Software.

6. PROPRIETARY RIGHTS

You acknowledge and agree that the Software and any necessary software used in connection with the Software ("Software") contain proprietary and confidential information that is protected by applicable intellectual property and other laws. Except as expressly authorised by HITS-UK, you agree not to modify, rent, lease, loan, sell, distribute or create derivative works based on the Software or the Software, in whole or in part.

HITS-UK grants you a personal, non-transferable and non-exclusive right and license to use the object code of its Software on a single computer, provided that you do not (and do not allow any third party to) copy, modify, create a derivative work of, reverse engineer, reverse assemble or otherwise attempt to discover any source code, sell, assign, sublicense, grant a security interest in or otherwise transfer any right in the Software. You agree not to modify the Software in any manner or form, or to use modified versions of the Software. You agree not to access the Software by any means other than through the interface that is provided by HITS-UK for using in accessing the Software.
